ΠΡΟΟΙΜΙΟΝ.

Ἐπὶ ἀναφορᾶς τοῦ Γενικοῦ Θεσαυροφύλακος, χρονολογούμενης τῆ 27 Οκτωβρίου 1853, καὶ ἐπὶ διαγγέλματος ἐκ μέρους τῆς Αὐτοῦ Εξουχότητος τοῦ Λόρδ Μεγάλου Ἀρμοσσοῦ, ἡμερολογουμένου τῆ 28 Οκτωβρίου 1853, δυνάμει τῶν ἐξουσιῶν τὰς ὁποίας τὸ μεταβύθηθὲν 16.ον ἄρθρον τοῦ γ΄ Τμήματος τοῦ β΄ Κεφαλαίου τοῦ Συντάγματος παραχωρεῖ εἰς τὴν Γερουσίαν, τῆ ἐξουσία τῆς Αὐτοῦ Υψηλότητος τοῦ Προέδρου καὶ τῆς Ἐκλαμπροτάτης Γερουσίας, καὶ τῆ ἐπιδοκιμασία τῆς Αὐτοῦ Εξουχότητος τοῦ Λόρδ Μεγάλου Ἀρμοστοῦ τῆς Προστάτιδος ΑΝΑΣΣΗΣ, νομοθετοῦνται καὶ διατάσσονται τὰ ἑξῆς.

ACT OF GOVERNMENT

Admitting the British Silver Florin into the Tariff of these States.

Corfu, 5th. November 1853.

PREAMBLE.

Upon a Report of the Treasurer General, dated 27 October 1853, and a Message of His Excellency the Lord High Commissioner, dated 28 October 1853; in virtue of the Powers granted to the Senate by the reformed 16th. Article, 3rd. Section, 2nd. Chapter, of the Constitution; by the authority of His Highness, the President, and the Most Illustrious the Senate, and with the approbation of His Excellency, the Lord High Commissioner, of the Protecting SOVEREIGN, it is decreed, and enacted as follows:

Art. 1. The Silver British Florin shall be admitted into the Tariff of the these States, and valued at two hundred and forty grains.

Art 2. The present Act shall be printed, published, and transmitted to the proper authorities, for its due execution.
